This form is to be completed by existing PVYC members at the start of each year and **MAILED** with payment of annual fees to the above address by **January 31**. **If your completed application and 50% of all fees, including winter boat storage, are not postmarked by January 31, your application will not be accepted and your membership will go to the bottom of the wait list.** As long as your first payment is postmarked by January 31, an invoice will be sent out in early March with the full balance due to the PVYC by March 31. **If the balance payment is not postmarked by March 31, the application will not be accepted and all fees will be returned minus a \$50.00 administration fee.**

**Important note: Application will not be accepted if money is owed from the previous year, e.g. work party assessments, winter boat storage, etc.**

**Committee Choices /Assessment Fee**

The Pioneer Valley Yacht Club is a cooperative membership organization. Members are required to either serve 15 hours on a club committee each year or pay an additional annual fee of \$450. Members who sign up for a committee and do not complete the required 15 hours of committee service will be assessed in the fall at the rate of \$30/hour.

**Committees are: Dock, Race, Social, Boatyard, Grounds, Pool, House and Membership**

Preferences for committee choice will be honored whenever possible. However, the PYVC reserves the right to make assignments as needed to properly run and maintain the club. Any member, who has not heard from his/her committee chair by mid-May, should contact that chair to determine the work plan/schedule for the year. **Members who do not complete the required 15 hours of committee service will be assessed in the fall at the rate of \$30/hour.**
